Innovation Procurement

The aim is to promote **innovation** from the perspective of demand (public sector). **CDTI Innovation** plays a crucial role as enhancer accelerating Business R&D to close the technological gap of those solutions whose technology is not yet near-to-the-market but could be achieved by financing R&D activities



- **Public Entities: modernization**

Public entities acquire first hand innovative products or services that meet their needs (early adopters) to face overcoming challenges that are not reachable in the market

- **Companies**

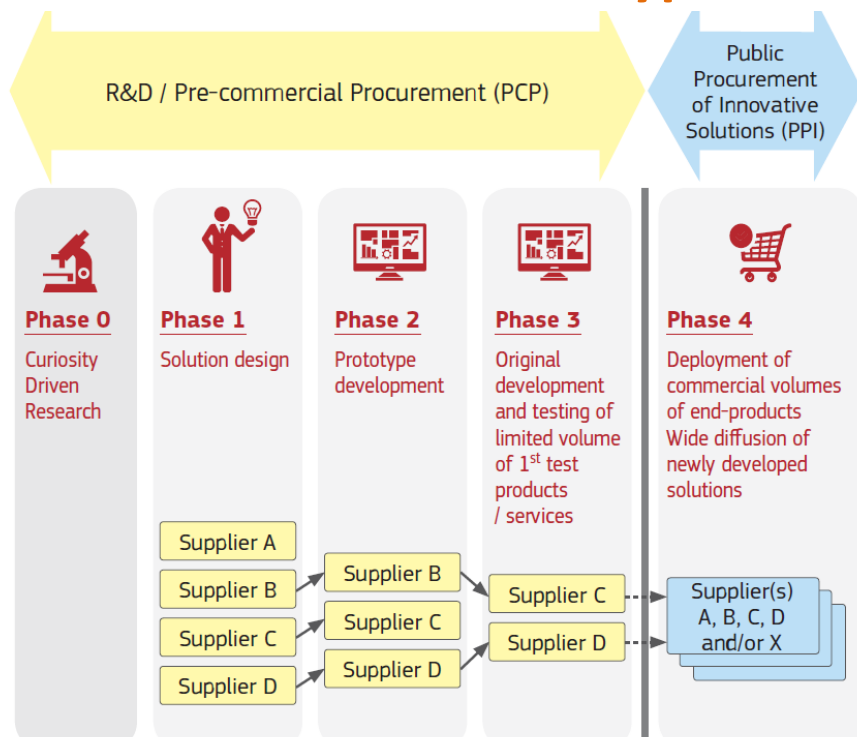
Provides a real testing environment for technology validation that would serve to obtain a first customer reference and gain international leadership in new markets.

Pre-Commercial Procurement (PCP)

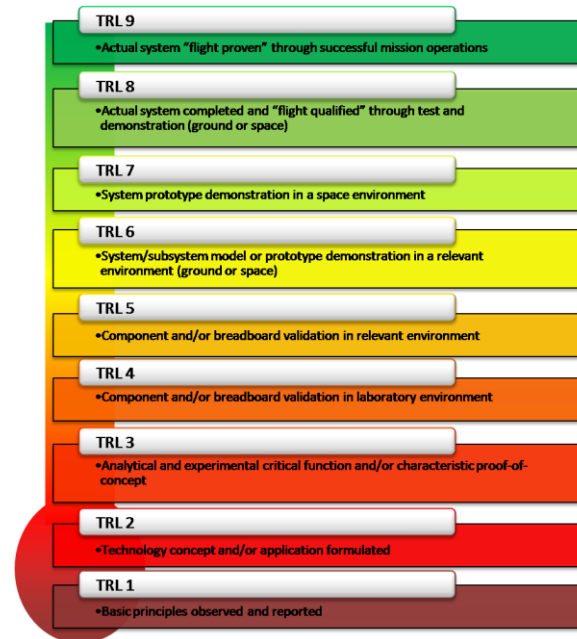
- R&D services' purchase for pre-operational prototype development (>50% of the contract)
- Buyers do not reserve IPR for themselves. Risks and benefits shared with developer.
- **No under Spanish Public Procurement (LCSP (art. 8))**, but maintains it's main principles: publicity, concurrency, equality, confidentiality, transparency and no discrimination principles
- TRL: 4-7 (from validation in laboratory to precommercial validation)

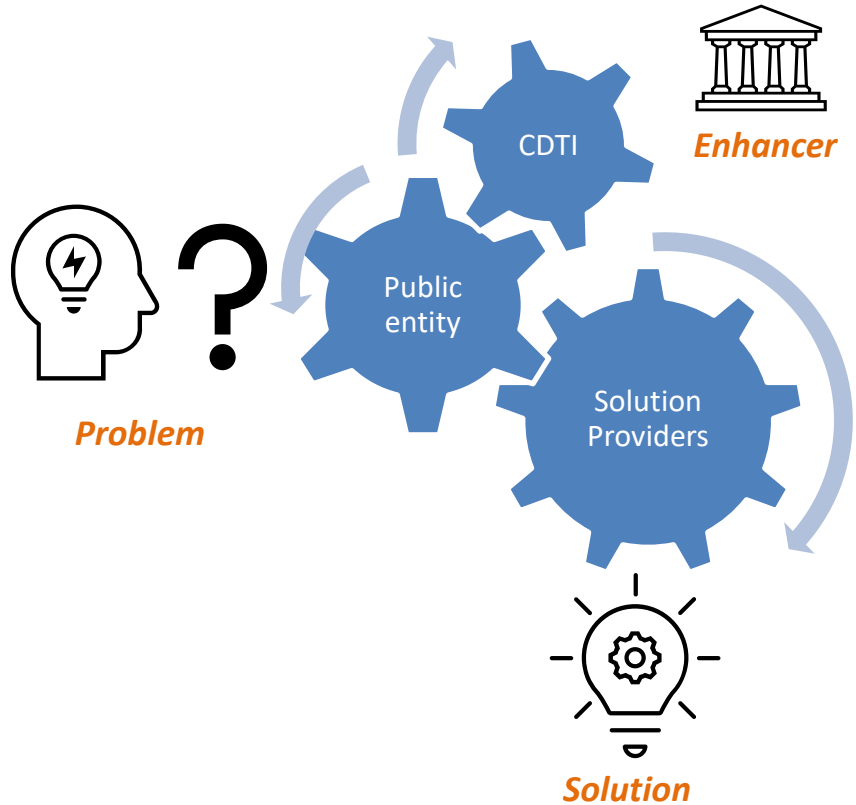

PCP GOVERNANCE in CDTI

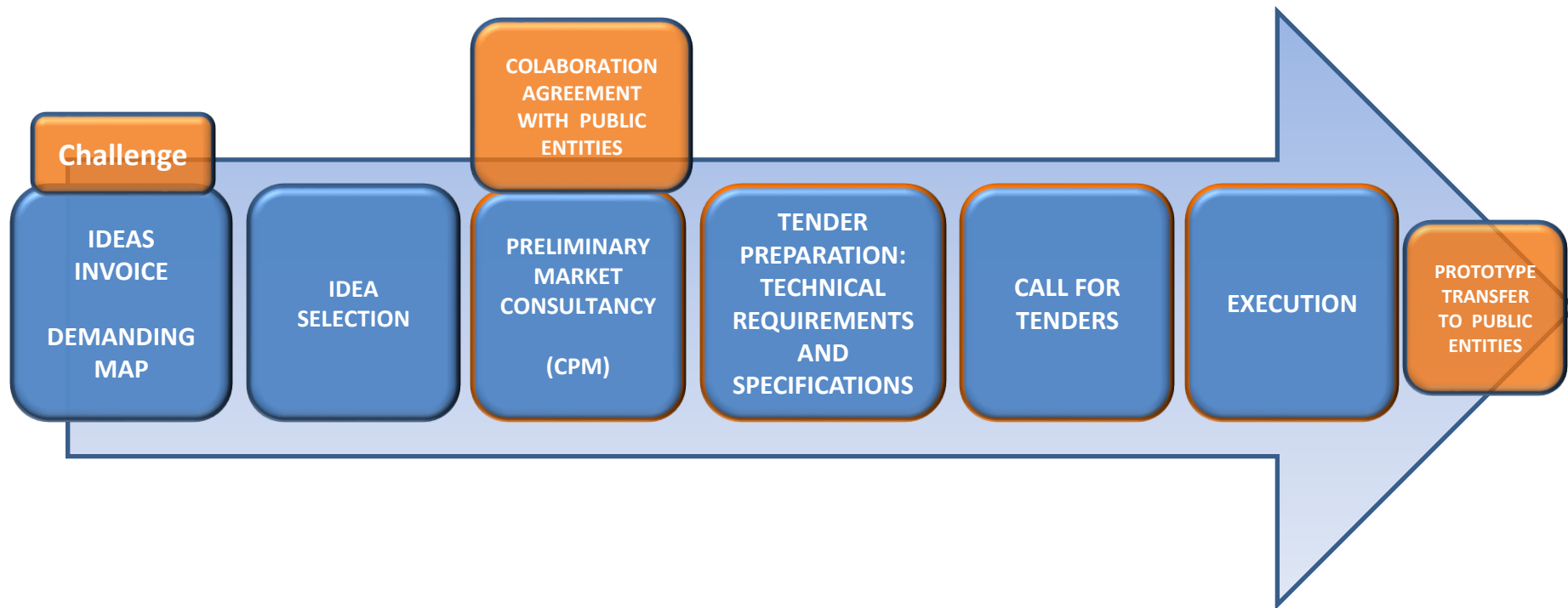


- El CDTI acts as **R&D services tender (buyer)** for technological validator/prototype development.
- Market non-existing technology development (TRL 4 a 7).
- Technology demanded by the rest of Public Entities, who act as validators in real environment.
- Developed prototypes are transferred to validator Public Entities without any cost.

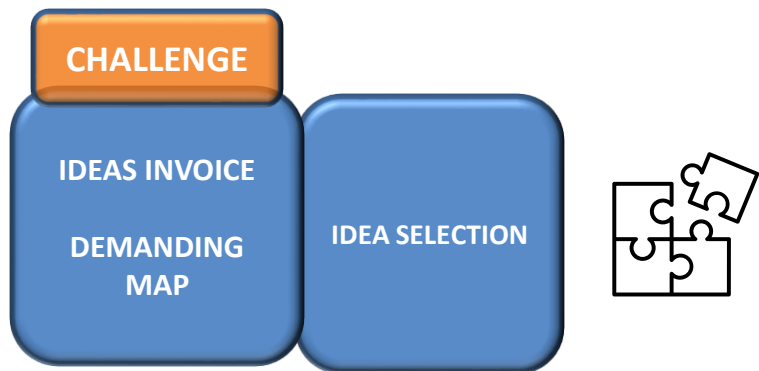

HADRONTHERAPY CHALLENGE



TECHNICAL CLAUSES

State of art

Cáncer is one of the biggest challenge of our actual society. **New therapies such as protontherapy have emerged. Among them, new cáncer therapy through ions. Hadron therapy would offer a considerable dosimetric optimitation and a higher radiobiologic efficacy.**

Needs detected

1. **Equipment simplification: a more compact linear Accelerator for hospital space restrictions and more economical.**
2. Increase radiation efficacy in each sesión, reducing number of sesiones for each patient.
3. Increase precisión in each radiation sesión, avoiding second effects to adyacent tissues and matrices.

Challenges

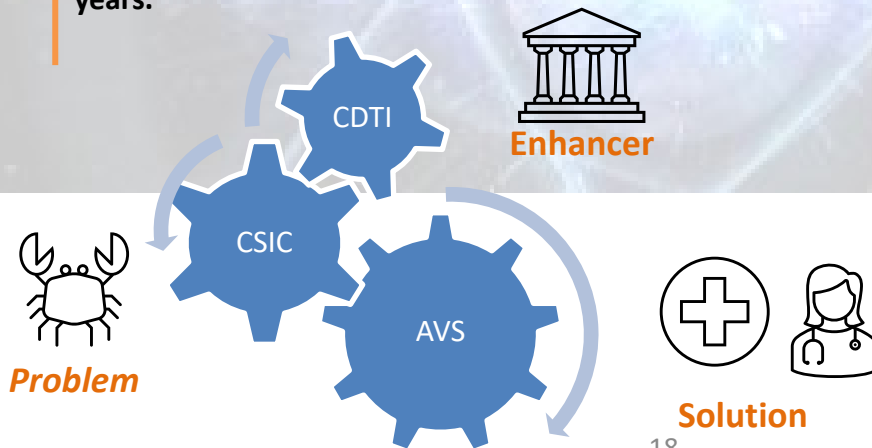
Desing, development and integration of a compact ion C⁶⁺ inyector of at least 10MeV/nucleon energy based in a linear Accelerator for radiobiological studies for hadronic treatment.

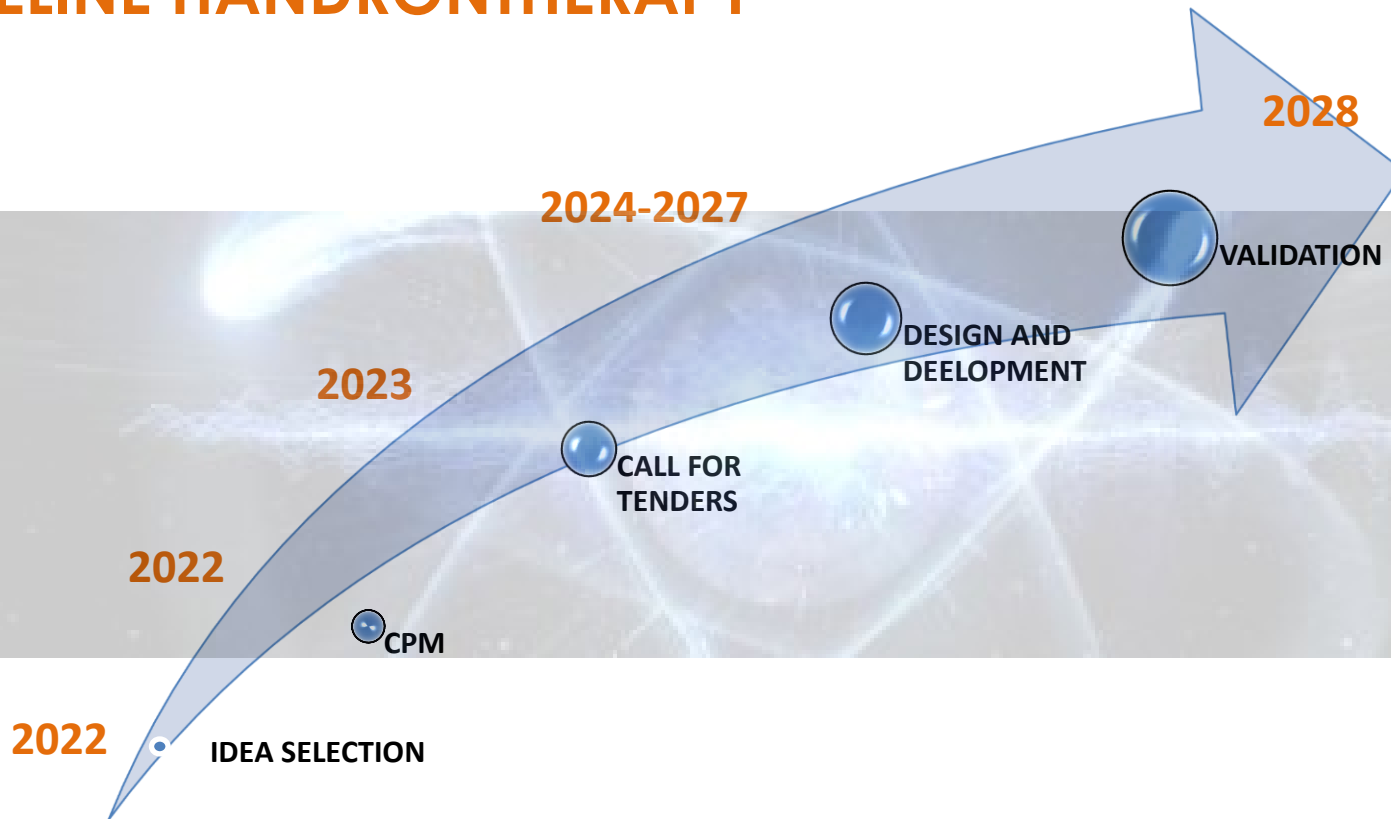
